(date / venue T.B.A.) The Dayton Band Playoffs have proven instrumental in underlining the abundance of talent to be found in Dayton. The Playoffs bring recognition to Dayton bands and The Miami Valley Region for it's thriving (and at times struggling) music scene. By working together with talented, hard-working, ambitious musicians Canal Street Tavern pledges to produce the best, most objective and totally honest contest possible. The Playoffs have made a difference in the success of many bands over the years. So, good luck- please join in our cooperative efforts to have some summer fun and a little friendly competition.

### **RULES AND REGULATIONS: (KEEP PAGE 1 & 2 FOR REFERENCE)**

#### **ALL BAND MEMBERS - READ THESE RULES CAREFULLY!**

Complete and return registration form found on page 3, with required fee. All band members must sign forms. If band members change, new band members must sign this document.

**THE STAGE MANAGER / HOUSE SOUND ENGINEER IS IN CHARGE OF STAGING AND PRODUCTION OF EACH SHOW. HE WILL HAVE FINAL SAY CONCERNING STAGE SET-UP, SOUND CHECK, START TIME, EQUIPMENT USE, AND ANY PRODUCTION OR PRESENTATION QUESTIONS PERTINENT TO THIS CONCERT SERIES.**

- A. The number of bands is limited to the first 48 bands to register.
  - 1. A \$40.00 registration fee is due with registration. If registering by mail pay w/ check or money order. Cash accepted only if paying in person.
  - 2. A band is not officially registered until the signed registration has been received and fee has been paid.
- B. Each band member must have ID showing age EVERY TIME THEY ENTER OR PLAY.
  - 1. Musicians under age 18 must be accompanied by parent / legal guardian at all times.
    - a. This rule may be waived during sound check only ; If parent is not present at showtime the player cannot participate.
- C. Load-in and sound check is at 7:00 sharp.
  - 1. Each band will use CANAL STREET TAVERN'S house P.A. and light system.
    - a. Use of extraneous P.A. equipment or lights is not allowed.
  - 2. Bands draw straws at sound check to determine order of performance. ( if no member is present by 7:15 P.M. that band defaults / first choice is given to band(s) who are present.)
  - 3. Any band late for load-in may lose opportunity to sound check.
  - 4. Any band not set up and ready to play at scheduled time may forfeit round.
  - 5. Bands must cooperate as quickly, efficiently and professionally as possible. during set-up, break-down, or striking of equipment before and after each set

### **RULES AND REGULATIONS *(continued)***

- D. Ballots will be available when the box office opens at 8 P.M. each night .**
1. Only paying customers over 18 will receive a ballot and be permitted to vote.
  2. A 'NO FREE RE-ENTRY' POLICY will be strictly enforced; and **ONLY ONE BALLOT WILL BE GIVEN TO EACH CUSTOMER PER NIGHT NO MATTER HOW MANY TIMES HE / SHE PAYS TO RE-ENTER.**
  3. Ballots are counted after last set by Canal Street rep. and members of each band.
  4. Each band is paid from the door receipts based on the number of votes received.
    - a. Round 1 & 2 - \$1 per vote • round 3- \$ 2 • round 4- \$ 2.50 • finals- \$ 3
- E. FIRST ROUND ONLY (Three bands per night.)**
1. Each band will play one set. Sets must be between 45 and 55 minutes in length.
  2. Sets will begin promptly on time - set 1 @ 9:30 pm ; set 2 @ 10:45 ; set 3 @ 12 AM
  3. Any band not set up and ready to play on time may forfeit round.
  4. Set changes will be accomplished as quickly and professionally as possible. The bands must cooperate efficiently during set-up, break-down, or when striking equipment before and after each set.
  5. At the end of round one, the top 24 bands (determined by vote count) qualify for round two ; the others are eliminated from further competition. (In case of tie, new date will be set and those bands will replay to break tie.)
- F. ROUND TWO, THREE, and FOUR (Two bands per night.)**
1. Each band alternates playing two 45 to 55 minute sets per night.
  2. Sets must begin on time: set 1 - 9:00 ; set 2 - 10:15 ; set 3 - 11:30 ; set 4 - 12:45.
  3. The band with the most votes wins and moves on to next round, the losing band is eliminated from further competition (In case of a tie, bands will replay to break tie.)
  4. Bands will typically have at least 2 weeks between next scheduled play date. Playoff dates (except the Finals) are never scheduled on Fridays or Saturdays
